DISCOVERY BENEFITS (WEX) SPENDING ACCOUNT STEPS

With enrollment now behind us, we look forward to the new year with Acadia's new spending account administrator, Discovery Benefits, a Wex Company. To access your account, please refer to the steps below.

Confirm Your Account

Employees that actively enrolled in FSA or HSA for 2021 would have received their new Discovery Benefits (WEX) benefit card(s). Participants would have also received an enrollment confirmation email from **Auto_Reply@mailer.discoverybenefits.com**, containing instructions to log in to your account. Once logged in you can see your account balance details, submit claims, request reimbursements, and request additional debit cards by selecting "Banking/Cards" under "Accounts."

Transfer of HSA Funds

If you have an HSA account through WageWorks/ HealthEquity or another administrator, you can easily transfer the balance to Discovery Benefits by completing the Health Savings Account Transfer Request Form.

Transfer fees will be waived for funds transferred from WageWorks to Discovery Benefits before March 31, 2021. After this date, a fee will be charged.

Download the App

Access your account on-the-go by downloading the Benefits Mobile app at **www.discoverybenefits.com**. From the app, you can:

- + Check balances and view account activity
- + Use the expense scanner to determine if your expense is eligible
- + File a claim and get instant status updates
- + Report and replace a lost or stolen debit card

SAVE TIME AND MONEY WITH MAINTENANCE MATTERS

If you need maintenance medication to treat a chronic condition, such as high blood pressure or diabetes, you will want to know about the Maintenance Matters program from BCBST. This program allows you to save time and money. To participate, you must get your maintenance prescriptions filled in a 90-day supply via home delivery or retail pharmacy in the Plus90 network. To learn more about this program, call the number on the back of your BCBST ID card.

With Maintenance Matters	Without Maintenance Matters	
Option to stay at home while your prescription is delivered or pick up at retail pharmacy	Drive to retail pharmacy every month to fill prescription	
\$20 copay for generic prescription	\$10 copay for generic prescription	
90-day supply	30-day supply	
Lower cost per refill for 90-day supply (1 refill x \$20 copay = \$20)	Higher cost per refill for 90-day supply (2 refill x \$10 copay = \$20 + Next refill outside of grace fill at full cost of drug*)	

* Drug fills/refills through the Maintenance Matters Program require you to provide a 90-day prescription from your provider. Participants can obtain 2 grace period fills (2-30 day supplies) through their retail pharmacy.

Request Your 90-Day Supply

Ask your pharmacy to contact your doctor for a 90-day supply of your medication.

Jump start your new year in the right direction—by saving for your retirement future.

If you are not already enrolled in Acadia's 401(k) plan, you can start participating now. If eligible, you may also receive free contributions with Acadia's employer match.* Enroll today by contacting Empower at 866.467.7756 or by visiting www.empowermyretirement.com.

* The employer match it 25% on the first 4% of your deferrals. You are eligible to receive the employer match if you are employed on December 31st of the year for which the match is calculated and completed at least 1,000 hours of service within the plan year. The plan includes a 4-year graded vesting schedule for employer matching contributions.

Contributions may be designated as traditional pretax contributions, after-tax Roth contributions, or a combination of both without exceeding the IRS annual limit. As you work on your taxes, you might want to ask your tax advisor about whether you should make traditional pre-tax contributions or Roth after-tax contributions to the 401(k). Pre-tax contributions give you a tax break right away, and your paycheck will benefit, but you'll pay taxes on withdrawals when you retire.
